1. INTRODUCTION

- 1.1 Benchmarking is a common practice and sensible exercise to establish baselines, define best practices, identify improvement opportunities and create a competitive environment within an organization. At its best, it can be used as a tool to help the University evaluate and prioritize improvement opportunities.
- 1.2 Benchmarking focuses on measures such quality, time, cost, and effectiveness; and is an ongoing process which assists in identifying possible performance issues. There are several forms of benchmarking and they can be categorized in various ways, but primarily the University uses the following:
 - a. Internal benchmarking: involves the University comparing its performance in certain areas with the same data from prior years and/or another area of the University.
 - b. **External benchmarking:** involves comparing the University's position within the Higher Education Sector as a whole or with a section of it in order to identify sector leading performance targets. This helps inform the University about whether internal performance targets and achievements are comparable, better or worse than its competitors or the sector as a whole.
- 1.3 The Higher Education Statistics Agency (<u>HESA</u>) collects, analyses, assures and publishes information about UK Higher Education and is a useful source of data against which to compare the University's performance across various categories: UK-Wide, Wales, quartiles, universities of a similar size or with similar characteristics.
- 1.4 HEFCW publishes an Information Toolkit for Governors periodically, and this is reviewed

by the Board of Governors upon publication. This provides a retrospective comparison of Welsh Universities' performance, based on HESA data, around financial health, students and quality, research and knowledge transfer, equality and diversity, and estates.

1.5 The Board of Governors has established a set of Reporting Key Performance Indicators (KPI) linked to the University's Vision and Strategy 2025. Where feasible and appropriate, external benchmarking data are provided, in addition to internal data, against KPIs for the Board to assess performance in the wider context as well as against internal targets and past performance.

2. BENCHMARKING DATA

2.1 The following data sets have been established for the Board of Governors to assist in effective evaluation of the actual and comparative performance of the University.
