Module aims

This module aims to equip students with an understanding of the criminal justice system, focusing on the police's role and their interactions with diverse communities.

Module Learning Outcomes - at the end of this module, students will be able to:

 - <u>Criminal Justice System:</u> Explain the key purpose of the criminal justice system and role of the police within it 1.1,1.2.
 - <u>Criminal Justice</u> Understand the court process, including interpretations and analysis that can be drawn from evidence given 4.1.
 - <u>Valuing Diversity and Inclusion</u>: Evaluate how the diversity of individuals and society impact on the criminal justice system 1.1;1.2.
 - Suspect and Offender Management: Understand the various types of justice outcomes, both judicial and non-judicial 6.1,6.2
- 2 Identify the legal processes and authorisations associated with arrest, detention and disposal of a suspect.
 - <u>Suspect and Offender Management</u>: Explain the processes for detaining and escorting a suspect to custody: 7.1, 7.2;7.3;7.4;7.5.

Assessment

Indicative Assessment Tasks:

- 1. Practical 15 mins Role Play Exercise: Students are to engage in a simulated custody environment, where they will actively participate in processes including the arrest and detention of a suspect.
- 2. Written Assignment Criminal Justice System Journey Map: Students are tasked with creating a detailed map of the criminal justice system and relevant legislation. Words: 1000.

Learning and Teaching Strategies

The learning and teaching strategy are grounded in the University's commitment to an Active Learning Framework (ALF) so that learning will be both accessible and active and include synchronous and a-synchronous elements. Face to face classroom teaching will be supplemented by online lectures wherein students will be expected to complete activities such as watching Panopto videos; undertake Other Indicative Reading; complete quizzes and exercises; and post comment for a-synchronous debate. These activities will be the subject of formative feedback by the module tutor. Added to this, will be access to staff who provide presence, challenge and support for student learning and can relate learning to real world uses.

Indicative Syllabus Outline

LO1. Evaluate the contribution of the police to the CJS it and how practices can respond to diversity of individuals and society.

- How the diverse nature of society impacts upon the criminal justice system; the importance of diversity and inclusion and the necessity for integrity and fairness across all criminal justice system matters.
- How socio-economic, mental health, diversity issues can impact on individuals progressing through the criminal justice system.

LO2. Identify the legal processes and authorisations associated with arrest, detention and disposal of a suspect.

- Police roles in relation to detaining and escorting a suspect to custody, including arresting officer, custody staff etc.
- Police service obligations and considerations relating to suspects e.g., benefits of an early arrest.
- How to use the police caution.
- Examples when discretion could be used, including managing and recording use of 'out-of-court' disposals.
- Understand legal processes and authorisations associated with bail:
- Roles associated with bail processes, including pre-charge, authorisations etc. including setting and managing bail conditions and conferring with victims regarding these.
- Importance of necessity and proportionality in the decision-making processes for using bail, including street bail.
- Bail periods and extensions, including processes associated with these (e.g., legal representation etc.).

LO3. Explain the importance of building and developing processes and relationships with key criminal justice partners and stakeholders

- Importance of understanding the influences on charging
- Considerations regarding the decision to charge, including setting out the charge correctly
- How a prosecution is undertaken and how to work with CPS lawyers



LO4. Demonstrate a knowledge of the process for recording, building effective case files and managing exhibits.

- Incident and crime recording standards.
- Different types of case file, their associated contents, including electronic case files and timescales / constraints associated with submitting these.
- Skills and documentation associated with effective case management and case files, including engagement with others to build the case file.
- Considerations to support 'Better Case Management' (BCM) and the national file standard
- The court process, including the types of courts, legal proceedings, hearings and their purpose.
- How actions at the court stage can affect the prosecution
- How evidence is presented to court and evaluated in a case, including:
- Preparing an evidence file for prosecuting authority
- Defence tactics that may be used, including inducement defence and their potential impacts.
