- Risks and benefits associated with conducting a traffic stop
- Use of intelligence and other data insights in directing roads policing activity
- Strategies to disrupt and reduce criminal and terrorist activity.
- Agencies and organisations that contribute to disrupting roads related criminality

# LO4: Explain appropriate investigative actions when responding to and attending incidents on the roads.

- Options available for disposal of driving and vehicle offences and when they are appropriate.
- How to take control of a scene as an investigator, including managing the safety of self and others
- Importance of keeping and maintaining accurate records, including disclosure considerations and tasking of others remove.
