Assessment

Learning and Teaching Strategies

The learning and teaching strategy are grounded in the University's commitment to an Active Learning Framework (ALF) so that learning will be both accessible and active and include synchronous and a-synchronous elements. Face to face classroom teaching will be supplemented by online lectures wherein students will be expected to complete activities such as watching Panopto videos; undertake Other Indicative Reading; complete quizzes and exercises; and post comment for a-synchronous debate. These activities will be the subject of formative feedback by the module tutor. Added to this, will be access to staff who provide presence, challenge and support for student learning and can relate learning to real world uses.

Indicative Syllabus Outline

LO1 - Examine Best Practice in Conducting Investigations.

- Key considerations associated when conducting investigations.
- How to identify lines of enquiry and associated investigative strategies.
- Potential overlap between one type of investigation to another (e.g., domestic abuse and assault).
- Importance of agreeing jurisdiction when an investigation crosses force or international boundaries.
- How to undertake an evidence-led investigation / prosecution where the victim is reluctant to support or withdraws from an investigation.
- Principles associated with conducting investigations.
- Importance of a suspect focused investigation.
- Partnership and multi-agency working, including referrals to other reporting mechanisms.

LO2 - Develop Skills for Ethical and Effective Interviewing of suspects.

- Processes associated with the interviewing of detainees.
- Considerations in relation to conducting suspect interviews.
- Core principles and considerations associated with investigative interviewing,



LO3 - Demonstrate an in depth understanding of the Procedures for Managing Suspects and Offenders.

- Identifying/detaining suspects, if still at scene
- Identifying, assessing, and managing of:
 - Perpetrators of offences.
 - Risks posed by suspects/potential abusers.
- Processes for managing offenders and suspects, including those who are vulnerable.
