Module Aims

This module aims to equip students with a deep understanding of community policing, focusing on effective communication with the media and communities, addressing community trauma, and enhancing engagement strategies for community cohesion. It explores the challenges and future directions of community policing, emphasising the importance of values, ethics, and diversity. Through critical evaluation of policing practices and problem-solving approaches, students will learn to foster positive relationships and promote community cohesion, preparing them for the complex dynamics of policing in diverse communities.

Students will deliver a multimedia presentation covering several key aspects of community policing.

Learning and Teaching Strategies

The learning and teaching strategy used in the module is grounded in the University's commitment to Universal Design for Learning (UDL), the key principle of which holds that students are encouraged to participate in higher education when they are exposed to flexible ways of learning by staff that engage them in different ways using innovative and creative approaches. - Importance of avoiding and mitigating community trauma to improve policing relationships.
- Public views and expectations of police contact
- Importance of community policing
- Role of community policing in addressing key issues, including the importance of engagement with other policing units and agencies e.g. response, social services etc.
- Impact on communities resulting from police responses to national emergencies / disasters and subsequent inquiries.
- Methods used to deliver effective policing to the community.

LO3: Critically evaluate the impact that key incidents and events have had on the future role of community policing.

 National and local incidents / emergencies/ disasters, including those which have affected the community relationship with the police, including those that have negatively impacted police and black community relationships.

LO4: Critically evaluate problem-solving approaches and their application to promoting community cohesion.

- How prevention is influenced, by and influences community policing approaches, including different models of policing e.g., problem-oriented policing
- Values, ethics and norms within diverse communities and how community demographics may change in the future.
- Barriers that may be experienced by individuals, based upon personal characteristics, including physical, psychological or physiological barriers.
- How multi-cultural differences may affect interaction between individuals, groups and organisations and the police.
- Effective engaging, consulting and working with diverse communities.
- Approaches to reduce community tension and enhance community cohesion.
