Learning and Teaching Strategies:

The module uses a blended approach to learning and teaching, including 6 hours face to face contact at Glyndwr University, supported by 12 hours online learning via Blackboard and 22 hours focused practice experience including mentoring and supervision in the workplace. Contact hours will include lead lectures, group work and reflective discussion. An experiential, work based approach will be utilised in practice in which students will be allocated a assessor to provide induction, guidance, ensure that there are opportunities for observing others. Students will also be expected to meet with and gain feedback from their line manager at the beginning and end of the module in order to have their outline Personal Development Plan agreed.
