Assessment

Indicative Assessment Tasks:

This section outlines the type of assessment task the student will be expected to complete as part of the module. More details will be made available in the relevant academic year module handbook.

The module will be assessed over a number of smaller assessments across the academic year that will draw on the learning covered during each semester.

- 1) Attendance students must maintain attendance of 80% to meet the requirements of the professional qualification.
- Learning Journey Presentation Students will deliver an individual presentation outlining their personal and professional development to date using the principles of reflective practice. (10 Minutes)
- 3) Youth Work Values and Principles Essay Students will write a 500 word essay that explains the values and principles of Youth and Community Work.
- Presentation Students will apply group work theory to reflect on their experience of making a digital media resource in an individual creative presentation format (10 mins)
- 5) Reflection students will examine an ethical dilemma in practice, evaluating how youth and community work values and principles were applied (500 words)
