## Assessment

Indicative Assessment Tasks:

There are 3 elements of assessment for this module:

- 1) Attendance – students must maintain attendance of 80% to meet the requirements of the professional qualification.
- 2) Portfolio - Students will complete a professional portfolio that includes the following:
  - a. evidence of meeting the performance, knowledge and understanding criteria for the Youth Work NOS Area D
  - b. a personal and professional development plan
  - c. evidence of engagement in professional supervision; applying theory to practice and reflection on practice
- 3) Viva Voce – Students will undertake a viva voce examination to critically reflect on learning to date to identify future professional development needs. They will also discuss ethical dilemmas faced when planning and implementing strategy and youth work activities, and how these have been navigated in practice to ensure the effectiveness of youth work strategies and plans.

## Learning and Teaching Strategies

A variety of teaching and learning activities will be employed on this module, predominantly those that emphasises interactive learning and student participation. These will include practical classes and workshops; case studies and problem-based learning activities, class and small-group discussion, simulation and group work.

This module will adopt a Hy-Flex approach to teaching and learning, in line with the Active Learning Framework. This means that students can join the classroom in person or join synchronously online to engage in the learning activities. Sessions will also be recorded for students to engage with alongside asynchronous online learning activities to scaffold the learning from the module.

The placement portfolio will be made available in Welsh.
