Module aims

The primary goal of this module is to familiarise students with a contextual understanding of their subject area. The module aims to introduce students to critical thinking, fostering their ability to engage in critical analysis and structured processes of inquiry. By emphasising these skills, students will not only grasp the evolution of artistic practices in their discipline but also develop a deeper understanding of the broader cultural and historical contexts that have shaped these practices. Furthermore, the module seeks to cultivate students' curiosity, encouraging them to explore their individual interests within the contexts of art & design history. Overall, the module is intended to lay a solid foundation for students, equipping them with the essential tools to navigate and appreciate their chosen field.

Learning and Teaching Strategies

This module will primarily feature thematic lectures and seminars focusing on art and design, providing students with a comprehensive historical and contextual understanding.
