Module aims

The "*ARTICULATING*" module, students will concentrate on constructing a unified body of photographic work while honing the skills necessary to present it to the public. The focus will be on embedding each student's photographic practice within the broader contemporary art world and culture, accomplished through refining writing, verbal expression, and exhibition curation abilities.

The module strives to equip students for launching a sustainable photographic practice postgraduation by delving into portfolio development and diversity, crafting professional documents, writing and submitting applications, exploring cultural and commercial funding streams and conducting career research.

Moreover, the module aims to refine students' analytical writing and verbal communication skills, enabling them to effectively and confidently articulate the context and significance of their photographic works. This comprehensive approach ensures that students are well-prepared for the challenges and opportunities awaiting them in the realm of professional photographic practice.

Module Learning Outcomes - at the end of this module, students will be able to:

1	Curate a professional-level exhibition of photographic work that effectively communicates ideas and contexts to viewers

Learning and Teaching Strategies

Students will embark on a self-directed program of study, complemented by a variety of learning activities aimed at deepening their understanding of professional presentation strategies within the field of contemporary photography.

Technical, critical and creative workshops will centre on effective methods for professionally showcasing artwork, imparting insights into nuanced artistic communication. Individual tutorials and reviews will provide personalized guidance, honing students' abilities to articulate conceptual and theoretical dimensions.

Collaborative elements such as peer discussions and group critiques will be key to this module and will facilitate the exchange of perspectives and the receipt of constructive feedback. Through independent photographic practice, students can apply acquired skills to guide their personal projects. Additionally, visits to galleries and museums, and talks from industry professionals will broaden exposure to diverse artistic expressions, offering real-world contexts for grasping the professional presentation of photographic artwork. This multifaceted approach ensures that students cultivate a comprehensive skill set to navigate and present their work proficiently and professional.

The student is required to complete the thesis in three progressive stages:

Initial planning, Literature review, Draft submission

Throughout these stages, the thesis supervisor will provide guidance and constructive criticism. Simultaneously, the practical work will undergo a three-stage evolution, comprising preliminary development, practical development, and the exhibition stage.
