Module aims

This module aims to introduce the complexities of healthcare when working with patients and their carers in their own homes and within the wider community. It provides the foundations for the development of a competent, accountable practitioner who will question their actions and decisions when providing care. The module will apply relevant, legal, regulatory governance and policies relating to the devolved Welsh legislature. Additionally, the student will reflect on their own personal values examining how these inform and impact on their practice. The student will be an ambassador for their field of community nursing and will act as a role model to others, leading by example and be a positive source of knowledge to others in their nursing team.

Module Learning Outcomes - at the end of this module, students will be able to:

1	Critically explore and deliver specialist person centred care recognising where this is complex, unfamiliar, and in unpredictable situations whilst being proactive and using professional judgement to apply effective solutions. (SPQ proficiencies 1.1, 1.2, 1.3, 1.4, 1.6, 1.7, 1.12)
2	Examine current legal, regulatory and government drivers within health and social care policy and utilise these to underpin current practice. (SPQ proficiencies 1.5, 1.12)
3	Justify the importance of working in a team and the contribution of compassionate leadership to the delivery of person-centred care in a community setting. (SPQ proficiencies 1.8,1.9,1.10, 1.11, 1.13)

Assessment

Indicative Assessment Tasks:

This section outlines the type of assessment task the student will be expected to complete as part of the module. More details will be made available in the relevant academic year module handbook.

Formative Assessment:

- A) Multiple choice questions via MS Forms on conversational Welsh language within community nursing.
- B) Simulation scenario incorporating the following key concepts: Referral/ safeguarding/professional judgement/stigma/unpredictable risk/accountability and autonomy/ advocacy and working safely in the home.
Followed by reflection and simulation debrief, utilising the *HEIW Simulation Debrief Strategy*.

Summative Assessment:

Assessment 1: Digital Group Presentation of the outcomes of a simulated scenario they have encountered within their capacity as a student within the field of community nursing.



Students will be marked on their individual contribution and as a collective group. Equal weighting will be given when marking students' individual contribution and their participation in the collective group work, further information is available in the assignment brief.

Learning and Teaching Strategies

This module will be delivered via a 'blended learning' approach. Directed study tasks, which may include activities such as recorded lectures, discussion forums, quizzes, case studies, simulations and group tasks, key readings, reflective activities, or other appropriate learning activities, will be made available on the Virtual Learning Environment. The Flipped classroom approach will be utilised as far as possible to maximise the learning opportunities during synchronous sessions. Timetabled 'live' seminars/ sessions may be held (either in a physical classroom or via an online platform), to facilitate discussion and debate and support students to progress with their learning. These will be recorded when appropriate and made available on the VLE, encouraging deep learning by enabling content to be revisited and reflected upon at a time suitable for the student.
