#### Module aims

This module will develop students' understanding of different applied psychological professions, including the ways in which they are similar and distinct from one another. Students will also gain an understanding of the evolution and development of these professions from their inception to contemporary practice. The module will also revisit classic psychological theory and approaches (such as psychodynamic, person-centred, cognitive-behavioural, the biomedical model) and how they may have impacted upon different applied professions. Students will be encouraged to think about how practice may continue to evolve and consider what underpinnings will be relevant to different applied professions within the future.

#### Module Learning Outcomes - at the end of this module, students will be able to:

1	Evaluate different psychological professions and their application.
2	Critically evaluate theoretical underpinnings of modern psychological practice.
3	Critically discuss the role of applied psychological practice in relation to management of psychological conditions and/or disorders.

#### **Assessment**

Indicative Assessment Tasks:

Assessment 1: a 3000-word critical essay discussing an area of applied psychological practice (e.g., the theoretical underpinnings of clinical psychology).

## **Learning and Teaching Strategies**

A range of different learning and teaching strategies will be utilised in this module, including lectures, seminars, group and individual activities, directed and self-directed learning, and tutorials. Module content will include pre-recorded asynchronous online content that will inform synchronous sessions. This will allow students time to reflect on and further develop their knowledge ahead of consolidating learning through group workshops and/or seminars.

All learning and teaching methods are supported by the University's virtual learning environment, Moodle, where students will be able to access clear and timely information to support the delivery of content such as videos, links to relevant online information, discussion forums, and pre-recorded lectures.

The University's Active Learning Framework (ALF) is embedded within the module to achieve optimal accessibility, inclusivity, and flexibility in terms of teaching and learning. This is in line with the principles of Universal Design for Learning (UDL). A learning blend is used that combines synchronous and asynchronous digitally enabled learning with best use of online opportunities and on-campus spaces and facilities.
