Assessment

Indicative Assessment Tasks:

This section outlines the type of assessment task the student will be expected to complete as part of the module. More details will be made available in the relevant academic year module handbook.

Students are asked during a 10 minute online oral assessment to reflect upon their international learning experience and be prepared to respond to questions about what learned about themselves and how they interact with others, what steps they could take to further their ability to work in international/intercultural contexts, and provide reflective examples of challenges they had to overcome in preparing for and working in an unfamiliar environment.

The International Experience module will utilise an immersive approach to learning and teaching. These may include:

Experiential Learning

- Cultural immersion activities
- Participation in local events and customs
- Shadowing or internship opportunities with local professionals
- Field visits to relevant cultural and professional sites

Interactive Workshops

- Pre-departure online orientation sessions
- Cross-cultural communication workshops
- Problem-solving and adaptability exercises
- Comparative analysis seminars

Guided Reflection

- Group reflection sessions (virtual)



- One-on-one mentoring with academic advisors

- Group assignments with local students or professionals
- Community engagement initiatives
